## İZELTAŞ İZMİR EL ALETLERİ SANAYİ VE TİCARET ANONİM ŞİRKETİ APPLICATION FORM

İzeltaş, as the data controller has prepared this application form in order to enable data subjects to exercise their rights and to fulfill the obligation to inform, pursuant to Article 10 of the Personal Data Protection Law.

Pursuant to Article 11 of the Law on Personal Data Protection, you can exercise your rights by contacting İzeltaş and filling out the attached form:

- a) You can learn whether your personal data are processed or not,
- b) You can demand for information as to if your personal data have been processed,
- c) You can learn the purpose of the processing of your personal data and whether these personal data are used in compliance with the purpose,
- d) You can find out the third parties to whom your personal data are transferred in country or abroad.
- e) You can request the rectification of the incomplete or inaccurate data, if any,
- f) You can request the erasure or destruction of your personal data under the conditions referred to in Article 7.
- g) You can request reporting of the operations carried out pursuant to sub-paragraphs (e) and (f) to third parties to whom your personal data have been transferred,
- h) You can object to the occurrence of a result against yourself by analyzing the data processed solely through automated systems,
- i) You have the right to claim compensation for the damage arising from the unlawful processing of your personal data.

Pursuant to Article 13 (1) of the Personal Data Protection Law, you may submit your request regarding the exercise of your above-mentioned rights to İzeltaş in writing or in any other manner determined by the Personal Data Protection Authority ("Authority"). In this regard, your requests can be submitted to us free of charge by filling in this form, printing it out and submitting it to us using one of the methods below.

Third parties are not permitted to exercise the right of providing information on behalf of the data subject due to PDPL Article 11. If the data subject wants to make a request regarding personal data relating to another person, it is necessary to provide the signed and notarized original of the special power issued by the data subject on behalf of the requesting person.

Depending on the nature of the request, your requests submitted to us will be answered within thirty days of the receipt of the request, in accordance with PDPL Article 13 paragraph 2 of the Law on Personal Data Protection. We will send our answer in writing or electronically, in accordance with Article 13.
